COURSE DESCRIPTION

PROGRAMME OVERVIEW

In its 4th edition, this Executive Training course aims at developing and strengthening critical thinking and essential skills that pertain to managing the entry and presence of foreigners within the borders of the State. It offers original research findings and expert insights into the politics of migration, migration policy design, and implementation. Through an intensive three-day programme, the training provides a comprehensive understanding of migration management.

The key transversal themes discussed in this training are attitudes towards migration, public understandings of the phenomenon, policy design, and implementation. During this edition of the training, special attention will be given to labour migration programmes for low-skilled migrants, the adoption of the New Pact on Migration and Asylum in the EU, and reception policies for asylum seekers.

The training is tailored for junior to mid-career professionals dealing with migration. Knowledge from migration theory and empirical research will be combined with professional insights about challenges and opportunities arising from political processes, and practical perspectives that occur at the operational level. The training offers a unique setting to learn about cutting-edge research on migration management and network with a variety of professionals from academia, civil society, public administration, European institutions, and international organisations.

By the end of the training, participants will be able to use a holistic framework for migration management. They will develop advanced skills to anticipate the ethical, legal, political, and practical challenges involved in the regulation of migration. They will also learn to use original research findings as part of their work and connect with a wide range of important players in the field of migration management globally.

LEARNING OUTCOMES

By the end of this programme, the participants will be able to:

- Incorporate research findings about dynamics of migration and migration governance into policy design and practice;
- Learn about expert insights into the politics of migration and the challenges of migration policy design;
- Understand how public institutions can identify people's concerns and understand their motivations;
- Network with important stakeholders in the field of migration management.

What are the political challenges that arise when designing and upgrading first reception systems in democratic contexts?
